**WARRANTIES**


It is hereby warranted by the insured that:

1. An independent person not having a conflict of interest shall be stationed near the green at each designated hole and shall witness all shots made at the hole during the event.
2. Certification of achievement of the hole-in-one shall be made by the person witnessing all shots as referred to in number 1. above, the successful golfer/player, and the club secretary or golf course head professional.
3. Score cards will be completed.
4. The hole-in-one must occur during an official prescheduled event by a preregistered golfer/player.
5. No practice shots shall be permitted, no participant may shoot for another person, and all shots shall be made in a regular round of play.
6. The actual length of the designated hole(s), during the event stated above, shall not be less than the length stated in this form.
7. The applicant must send notice of claim no more than three working days after the event.
8. In the case of a hole-in-one, the insured must get the name(s) and phone number(s) of all other members playing in the foursome, the actual scorecard in the tournament, and the name(s) and phone number(s) of all monitors.
